Sl. No.	The approval of the Board for CHANGE OF NAME to the school is subject to following directions and conditions
1	The approval is based upon the documents /data/information uploaded by the school online. The Manager / Principal of the school shall be held responsible for its genuineness. In case of any document found to be fake/forged/fabricated/tampered, the application of the school is liable to be rejected and the school shall be liable for imposition of any of the penalties and necessary action will be initiated against the school as deemed fit, under clause 10.1.16 of Affiliation Bye Laws, 2018.
2	The school will not run any branch or part of school with old school name and will not use its old school name in any manner in future.
3	In case of land documents are presently in the old name of school, the school will be required to submit revised land documents in favor of revised name of school within one month.
4	The approval is subject to final outcome of pending legal case/ litigation and any other issues arising out of change of name of school and Board shall not be responsible for any dispute/legal issue arising out of change of name of school.
5	The liability of the school whatever before will be the liability of the school for all purpose, after change in name of school.
6	The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye-Laws, 2018.
7	The school should change all the records and letter heads in new school name.
8	The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
9	The school shall possess valid Recognition certificate, Fire Safety Certificate, Building Safety Certificate and Water Safety and Sanitary Condition Certificate along with other essential documents during functioning of the school which shall be renewed from time to time as per norms

10	The school may make provisions to establish Rain Water Harvesting systems in their school premises as per Board's circular no. CBSE/AFF./AC/RWH/ 2025 dated 24.03.2025.
11	Every affiliated school will develop their own website containing comprehensive information such as Affiliation status, details of infrastructure, details of teachers including qualifications, number of students, address-postal and e-mail, telephone numbers, copies of transfer certificates issued, etc. as may be directed by the Board from time to time. The website so created should also have information with regard to fees charged.
12	The school shall ensure that all essential valid documents and teachers details including qualifications, are available and upload updated self-attested copies of the documents/ information under the head Mandatory Public Disclosure (as per Annexure-IX) on school's website at all time and the link of certificates should remain functional. The school shall not remove the videography links from the Mandatory Public Disclosure (MPD) section of school's website.
13	The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
14	The school shall abide by the Affiliation and Examination Bye-laws of the Board mutatis mutandis .
15	Other conditions will remain in-force as per grant of Affiliation letter issued to the school.
CONDITIONS FOR COMPLIANCE Further, the school shall submit compliance on the following mentioned conditions within 03 months on the SARAS Portal from the date of the issue of grant letter i.e. upto 13/08/2026. Failure to submit the compliances within the stipulated time shall invite financial penalty of Rs. 50,000/- and appropriate action may be initiated as deemed fit as per Affiliation Bye-laws 2018 of the Board.	
1	The school must obtain all the documents in new name and upload these fresh documents on changed name i.e. THE RADIANT WORLD SCHOOL as Mandatory Public Disclosure on its website and keep these documents updated. School must ensure the changed name is reflected across documents and places including school building.
2	The school authority must ensure that all the Mandatory Public Disclosure documents must be uploaded and updated on the school website strictly as per Appendix-IX (SARAS 7.0 Manual) and remain accessible for all time. Further, it must obtain also be ensured that the documents links are opening properly.
3	The school authority shall be held responsible for genuineness of all the documents submitted. In case of any document/information is found to be fake/forged/fabricated/tampered, the application of the school is liable to be rejected and the school shall be liable for imposition of any of the penalties and necessary action will be initiated against the school as deemed fit, under clause 10.1.16 of Affiliation Bye Laws, 2018. Documents uploaded by the school are in order.
In case of partial acceptance of compliance, the school shall submit the remaining compliances within further stipulated period of 03 months. In case of the failure of the school to submit the final compliances, the Board may enhance the penalty amount and debar the school from filling up the Registration/LOC details of students of classes IX & X and class XI & XII, as the case may be, in the next academic session i.e. 2028-29 .
